Public participation

Exemption will also provide additional instructional days. Dennis parent. District needs to give more frequent and substantive updates to families & public. Dps not updated since jul 13th meeting. Delay of start of school is slide 8 out of 12. Dennis fam/parents who don't understand scope. No info been sent to neighborhood about upcoming year or how to navigate kindergarten registration. Need clarification on where to go. Need both mail & digital updates. Updates on timeline of academic year, especially busing and childcare. Need immediate updates on kindergarten registration and school supplies funding?

Amie dobernick. Professional in community, former dps parent, mother of dps teacher. Etc etc. Past 10 years unbecoming behaviors among board and central admin. Keil building / not my job to help oack boxes. I am nurse & in mgmt. Would never ask staff to do a job i wouldnt do myself. Central admin & chool board should be qilling to roll up sleeves or quit? Staff had short notice, may be on second job or vacation. 5 days notice, 3 days to pack up. Some were not able to. Said they could pack & lavel and district would move it. Concern about school supplies after osha complaint. Osha complaint day late, dollar short. You are making it very difficult to recruit healthcare workers to this area.

Nick krim. Monarch butterfly connection. Part of history students can be proud of. Dennis opportunity for metamorphasis. Develop a new "body and wings" now that students have a crysilis. Demolish or find a new building but dont dump money into repairing old buildings. Let 6th graders finish dennis at garfield?? Bring second assistant principal back to dennis.

Board discussion. Al scheider. Asks about supplies moving. Clark answers not all safe rooms were moved. They did priorities first (hume folders? Cume folders?). Brown. Asks about august public comment. Says that person was not taken seriously. Feels like that wasnt followed up on. Why wasnt it followed up on? Clark says she doesnt remember any parent saying that. She

says the minute she heard of it she started acting.

Master analysis. Have other schools been checked yet? Clark sats we're in the process and will ask permission at next board meeting to move forwars. Qill it be same firm? Clark doeant know. Dr curry. Provurement for professional services. Interview at least 3 then select 1.

Will asks if this will cover the 10 year hls too. Curry says hls on agenda for the 8th & that will be with bldd.structural from putside company.

Brown. If teachers cant get belongings do we have a plan for that? Reimbursement? Clark believes they will allow district back into building at some point and hopes il will see they have a safe plan in place and allow it.

Wetzel. how long to clear osha complaint? Clark. Legal is working on that.

on K-8 Magnet School contractor

Collins asks about bids or firm? Curry says will be awarding contract to a firm. Brown asks if we can inquire about the firm. BIDD steve. New K8 magnet school. 5 week provess about subcontractors and bids. 25 mil - 35 mil. Estimate was 28 mil. CU firm. They did international prep academy in champaign.

Brown asks about mbe goal. Bldd steve says ... fred coleman mentioned. Minority business enterprises. 15% minority? Christie foltz was a decatur company. Not sure if met mbe. Goal, not requirement. Brown asks if we're required to go with lowest bid?bldd says ye. Brown disappointed not a local firm.

Clevenger. Give us grand total where we are. Procured some package and some materials with long lead times. Full budget w/5% contingency, 33.5 million total project budget. Origibal estimate was 37 million.

Wetzel. When completed? Steve by end of 2025. Must be allotted by that time bc using ester?? Money.

Al thought it was 24. Steve said january of 2025. Brown votes no. 3 absent. Clevenger, scheider, wetzel voted yes.
