Dear Reed,

Thank you for writing to the City of Decatur with your request for information pursuant to the Illinois Freedom of Information Act, 5 ILCS 140/1 *et seq*.

Your request is for "memo regarding a September 7, 2019 meeting regarding cannabis, email threads that contained that memo, including replies and forwards, any documentation related to the September 7<sup>th</sup> meeting referenced in that memo".

Your request is allowed in part, and denied in part pursuant to the following Illinois Freedom of Information Act Sections, (5 ILCS 140/1 et seq.) containing the applicable exemptions identified below:

5 ILCS 140/7 1 Exemptions. (1) When a request is made to inspect or copy a public record that contains information that is exempt from disclosure under this Section, but also contains information that is not exempt from disclosure, the public body may elect to redact the information that is exempt. The public body shall make the remaining information available for inspection and copying. Subject to this requirement, the following shall be exempt from inspection and copying:

Copies of records responsive to your request are provided herewith, except for records exempt from disclosure pursuant to the exemptions below. Where messages contain both exempt and non-exempt information, exempt information has been redacted, also pursuant to the exemptions listed below:

Pursuant to Section 7 (1) (b), portions of the requested records constituting "private information" including personal telephone numbers, signature and email link have been redacted.

Pursuant to Section 7 (1) (f), preliminary drafts, notes, recommendations, memoranda and other records in which opinions are expressed, or policies or actions are formulated are

exempt from disclosure. This exemption applies to pre-decisional communications in which opinions are expressed, or policies or actions are formulated.

You have a right to have the denial of your request reviewed by the Public Access Counselor (PAC) at the Office of the Illinois Attorney General, 5 ILCS 140/9.5 (a). You can file your Request for Review with the PAC by writing to:

You also have the right to seek judicial review of your denial by filing a lawsuit in the State Circuit Court. 5 ILCS 140/11.

If you choose to file a Request for Review with the PAC, you must do so within 60 calendar days of the date of this denial letter 5 ILCS 140/9.5 (a). Please note that you must include a copy of your original FOIA request and this denial letter when filing a Request for Review with the PAC.



## Dear Macon County Mayor:

County Board Chairman Kevin Greenfield and I are convening a meeting of Macon County Mayors and Village Presidents to discuss recreational marijuana distribution facilities in Macon County. As you know, the General Assembly passed, and the Governor signed, House Bill 1438 (P.A. 101-0027) creating the Cannabis Regulation and Tax Act (ACT), which takes effect January 1, 2020. The Act impacts municipalities in a variety of ways.

I believe the enclosed document from the Illinois Municipal League provides a comprehensive list of considerations and subsequent actions that will be required of locally elected bodies. The Village of Forsyth has voted to opt out of having distribution in their city. Chairman Greenfield and I would like the Mayors/Village Presidents to meet collectively to begin conversations about the Act.

We invite you to join us on Saturday, September 7<sup>th</sup> at the Long Creek Township Building at 8:00 a.m. So as not to violate the Open Meetings Act, please feel free to bring only one additional elected official, and if applicable, your city administrator.
